4a (Code:) (Expenses \$ 753,501. including grants of \$ 1,163.) (Revenue \$) GoodWeave is disrupting the cycle of child labor, slavery, illiteracy, and poverty through the following interrelated strategies:

Harness Market Forces: From the garment factories of Bangladesh to the cocoa fields of the Ivory Coast, there are 160 million child laborers today. The rug industry has one of the highest levels and harshest forms of child labor-an estimated 200,000 children are exploited to weave carpets destined for elite showrooms and some of the most recognized retailers in the West.

4b (Code:) (Expenses \$ 739,215. including grants of \$ 19,013.) (Revenue \$ 911,102.) Develop Child-labor-free Supply Chains: Inspection, Monitoring and Certification:

GoodWeave certification offers the best assurance that rugs and textiles are made without the use of child labor. GoodWeave's inspection system is the only one that reaches all levels of the supply chain in an informal manufacturing sector. In 2021, GoodWeave's national inspection teams in South Asia reached more than 101,000 workers through monitoring visits to facilities, which also resulted in 4.5 million rugs and home textiles certified as child-labor-free. This work directly led to the rescue of 1,075 children from exploitation - the majority of whom were victims of trafficking.

In 2021, GoodWeave provided direct access to education to 18,950 children. GoodWeave teams in India and Nepal have continued to innovate program design, introducing education programs ranging from daycare and early childhood education programs in Nepal to establishing entire "child-friendly" communities throughout North India's informal worker regions. While the implementation model, scope and scale from community to community varies, the strategy behind doing this remains the same. These programs are designed with input from survivors and those proximate to needs, either serve child trafficking survivors and/or address the root causes.

GoodWeave employs a demand driven model. By establishing partnerships with brands and retailers, and increasing consumer preference for certified products, the organization is able to inspect more supply chains and protect more children. Efforts within the "Harness Market Power" category include building corporate partnerships and consumer awareness activities that increase market adoption of child-labor-free products in North America and Europe and other consumer markets worldwide.

In 2021, GoodWeave launched its "Tell Them I Made It" awareness campaign in partnership with its business, NGO and media partners. The campaign reached over 96 million people, through editorial outreach, public service advertising, social media, point-of-sale educational materials, special events, website marketing and other targeted outreach.

GoodWeave inspects the production supply chains of participating manufacturers and importers. To be certified and thus eligible to display the GoodWeave label, manufacturers sign a legally binding agreement to: (1) Produce products free from child labor and forced and bonded labor; (2) Register all production sites with GoodWeave and allow random, surprise inspections; and (3) Pay license fees that support child rescue, rehabilitation and education in India, Nepal and Afghanistan.

In 2021, carpet, home textile and apparel programming resulted in 16 new import and retail companies joining around the world, bringing the total number of licensees to 188 and resulting in more than 33% share of the total handmade rug market globally.

Form 990, Part III, Line 4b: Develop Child-labor-free Supply Chains: Every child found is offered rehabilitation, counseling services, schooling, and other critical services. In addition - and this is the most powerful point of impact - approximately 50,000 children were prevented from ever being exploited because of the regular, surprise visits made this year to workshops, factories, and private homes in artisan and producer villages.

In 2021 GoodWeave was a Code Compliant member of ISEAL, the global association for sustainability standards. ISEAL membership requires GoodWeave to obtain third-party assessment of its certification system to ensure the organization is independent of external pressure, is transparent in its certification process, demonstrates proper quality control and confidentiality systems, and treats all producers equally.

Standard Setting:

GoodWeave's certification Standard addresses the contributing factors to child labor. In 2021 GoodWeave strengthened its work to address conditions of forced and bonded labor across product categories from carpets to home textiles, apparel to fashion jewelry, as well as at various tiers of production from Tier One factories to home-based production. The Standard prioritizes three "certification principles"

including no child labor, no forced or bonded labor, and conditions of work are documented and verifiable. The Standard also includes progress principles, including freedom of association and collective bargaining are recognized; no discrimination is practiced; working conditions are respected, including workplace safety and health, wages, working hours, and disciplinary practices; and negative environmental impacts of production are identified and minimized.

GoodWeave removes children from slave-like conditions, reunites them with their families when possible, and offers them a home when not.

Rehabilitation can take years and includes psychological counseling in addition to health care and education. Rescued children are supported until grade 10 or age 18, whichever comes first. In 2021, 1,075 children were removed from exploitative labor across all program categories including carpets, apparel, fashion jewelry, tea, and bricks. These children were provided with educational support and rehabilitation.

This involved establishing remote audit and inspection and safety protocols and delivering humanitarian aid to vulnerable workers and families in

the supply chain regions of operation who had no safety nets.

GoodWeave's grassroots presence ensured urgent food aid; PPE and COVID-19 awareness; hygiene kits; special protections for rescued children; access to e-learning for children; banking support, access to vaccination; and more to over 173,000 individuals.

GoodWeave also successfully completed a 12-month project in Bangladesh to support vulnerable apparel workers as they face the impacts of the pandemic and released a short film entitled "Unseen: Informal Garment Workers of Bangladesh", which highlights project achievements.

Beyond the programs GoodWeave implements directly, the organization also seeks to improve conditions for all workers, to build the capacity of other organizations and serve as a thought-leader and advocate to raise the bar for companies, governments and other supply chain actors, to tackle child labor and its root causes.

In 2021 GoodWeave participated in numerous high-level events and advocacy platforms to promote the importance of ending child labor and modern slavery through deep due diligence practices that include full supply chain mapping, application of strong human rights Standards, ensuring remedy to rights holders and addressing root causes. These included the Ethical Trading Initiative; the Dutch Sustainable Textiles Agreement; and the German Government convened Textilbündnis.
