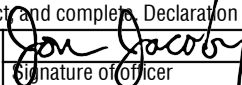

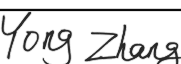

GoodWeave is disrupting the cycles of child labor, forced labor, modern slavery, poverty, gender inequality, and adverse climate impacts through the following interrelated strategies:

Harness Market Forces:

From the garment factories of Bangladesh to the artisanal cobalt mines of the Democratic Republic of the Congo, there are an estimated 138 million child laborers in the world today. GoodWeave employs a market-driven model to end child and forced labor. By establishing partnerships with brands and retailers and increasing consumer preference for certified, child-labor-free products in North America,

GoodWeave certification offers the best assurance that rugs and home textile products are made without the use of child and forced labor. GoodWeave's inspection system is the only one that reaches all levels of the supply chain, including and especially informal manufacturing sites. In 2024, GoodWeave's national inspection teams in South Asia reached 126,743 workers through monitoring visits to facilities, which also resulted in 1.15 million rugs and home textiles certified as child-labor-free.

In 2024, GoodWeave directly provided educational opportunities to 37,815 children. GoodWeave teams in India and Nepal have continued to innovate program design, introducing education programs ranging from daycare and other early childhood education in Nepal to entire Child Friendly Communities (or CFCs) in dozens of informal worker communities across northern India. While the implementation model, scope, and scale varies from community to community, the strategy behind CFCs remains the same. These programs are designed with input from survivors of child labor and those proximate to community needs in order to serve at-risk children and workers and tackle the root causes of labor abuse.

Europe, and other markets worldwide, the organization can inspect and monitor more supply chains and protect more at-risk children and workers.

Form 990, Part III, Line 4a: Harness Market Forces:

GoodWeave inspects the production supply chains of participating manufacturers and importers. To be certified and thus eligible to display the GoodWeave label, manufacturers sign a legally binding agreement to: (1) Produce products free from child, forced, and bonded labor; (2) Register all production sites with GoodWeave and allow random, unannounced inspections; and (3) Pay license fees that support restoring freedom to children, rehabilitation, and education in India and Nepal.

In 2024, carpet, home textile, and apparel programming resulted in new import and retail companies in several countries joining, bringing the total number of importer licensees and business partners globally to 194. This year, an estimated 30.8% of the global market for handmade rugs carried the GoodWeave certification label.

GoodWeave also continued a project funded by the Netherlands Enterprise Agency's (RVO's) Fund Against Child Labor (FBK). The project entitled "Child Labor Free Supply Chains - Deep Due Diligence for Dutch Companies" supports GoodWeave's work to eliminate child labor in carpet supply chains in India and Nepal, as well as an expanded effort to grow GoodWeave's presence in the Dutch market.

In 2024, GoodWeave restored freedom to 378 children across all program categories. Every child found is reunited with her or his family whenever possible and is offered rehabilitation, counseling, schooling, health care, and other critical services.

The unannounced, random inspections of workshops, factories, and private homes in artisan and producer villages prevent thousands of children from ever being exploited.

GoodWeave is a member of the ISEAL Alliance. Our system has been independently evaluated against its Codes of Good Practice -- a globally credible framework for voluntary sustainability systems.

Improve Conditions for all Workers:

Addressing child labor effectively requires more than simply prohibiting the practice as a matter of law, policy, or standard. One important part of the equation is ensuring that adult workers are better compensated and treated within their workplaces. GoodWeave seeks to improve conditions for at-risk workers, extending to 7,297 workers in supply chains in 2024 a range of services such as eye screenings and

Promote Best Practice:

The organization also conducts advocacy, promotes best practices, and builds capacity within other key actors based on our unique and effective model. Additionally, we conduct research and serve as a thought leader to help inform and educate companies, governments, and other systemic supply chain actors about how to address child and forced labor and their root causes effectively. Research initiatives conducted in 2024 to be published in 2025 include a study on child and forced labor risk in apparel supply chains in Bangladesh, and a study on potential links between climate change impacts and child and forced labor risk in the carpet and brick sectors in Nepal.

In 2024, GoodWeave continued to participate in numerous high-level events and platforms to advocate for ending child and forced labor through business uptake of deep due diligence practices that map supply chains fully, apply strong human rights standards, ensure remedy for rights-holders, and tackle root causes. Such advocacy included speaking roles at the OECD Forum on Due Diligence in Apparel and Footwear.

In 2024 and 2025, GoodWeave also made demonstrable progress on multi-year projects supported by the Netherlands (RVO) and the United Kingdom (Modern Slavery Innovation Fund) to assess and address child and forced labor risk in subcontracted apparel supply chain worksites in Bangladesh. Partnering with multinational apparel brands C&A and Delta Galil, the Rights Lab at the University of Nottingham, and the Bangladesh Labour Foundation, this research, advocacy, and capacity building work has begun to educate and transform the behavior of influential public and private sector actors about these risks in the hidden tiers of supply chains in the world's 2nd largest apparel exporting country.
